Our Summer Tae Kwon Do / Ku Shu Do (Karate) Program offers all the rewards of a regular martial art school with added benefits such as **BEING LESS EXPENSIVE** and a **CONVENIENT SCHEDULE** for parents. Classes will begin on May 28, 2024 and run until August 1, 2024. Each student will receive a uniform, tee shirt, and notebook at a one time cost of \$50.00.

We are a **NON CONTRACT** program. Students are **NOT CHARGED** for weeks they don't attend giving parents the flexibility to meet their budget needs. The fee is \$25.00 and is due **before each weekly session.**

If a student qualifies for rank promotions, testing will take place for his or her next belt and certificate one week before program ends. Boards to be broken will not be provided and can be purchased from Mr. Willee.

As in other activities and sports such as gymnastics, soccer, football, and baseball; certain safety equipment is required for timely advancement and/or competition. This will be provided to each student while enrolled during the summer at no cost.

## BIOGRAPHY

Mr. William Almodovar has been studying the martial arts since February 1983 and is the owner & CEO of The Karate Shop (martial arts supply company), Action Fight School (TV & film stunt institute), World Class Martial Arts (personal training center). While being a certified

<sup>th</sup> 8 Degree Black Belt Grand Master Instructor in Chang Moo Kwan - Tae Kwon Do, Okinawan Ryu Te - Ku Shu Do (Karate), & Okinawan Isshin Do Jutsu Kobudo (Weapons). He has and also continues to study a mixture of other martial arts (MMA) such as: Moo Duk Kwan, Chun Do Kwan, Ji Do Kwan, Wing Chung Kung Fu, Ryukyu Kempo, Shin Shu Ho Ryu, American Karate, Arnis-Kali (Escrima), and Hapkido.

From 1989 to 1992, he taught under the supervision of Master Jeff and Cindy Weagley. When The Weagley's moved to the state of Maine, he then went under the direction of 8<sup>th</sup> Degree Black Belt, Grand Master Dae Kyu Lee (the Weagley's Instructor) from 1992 to 1996. In <sup>th</sup>1994 he also began learning and training under 10 Degree Black Belt Grand Master Taika Seiyu Oyata until his passing on June 18, 2012. Mr. Almodovar continues to currently be under <sup>th</sup>the guidance of two instructors, 9 Degree Black Belt, Grand Master Tashi Ralph Hernandez of <sup>th</sup>Orlando, Florida along with 10 Degree Black Belt Grand Master Hanshi Greg Lindquist (Taika Seiyu Oyata's senior student). He has competed in numerous local and other southeastern state tournaments with various wins from first to fourth; accumulating numerous certificates, medals, plaques, and trophies from such events. He is a Georgia State Tae Kwon Do Champion.

Among many of his accomplishments as an instructor, his children, as well as students from his schools have also competed in various competitions nationally and won championships, recognition, and respect in the competition world. Several articles have been featured in newspapers recognizing him and his students for their accomplishments. Mr. Willie, as his students call him, has shared his expertise in the Martial Arts by conducting classes, seminars and demonstrations in churches, public schools, day cares, businesses, private communities, fitness centers, other martial art schools, and local TV shows.

In recent years, his expertise in choreography, stage fighting, and stunts has allowed him to showcase his skills in both big screen movies and small screen television. He also teaches and trains actors/actresses, young or old to perform stage fighting skills in the entertainment industry.

Mr. Willie has high goals for both teaching and continuing to grow in rank. He enjoys working with people young and old; helping them achieve their goals regardless of whether they are big or small. With much prayer, God's blessings, and your help, he will continue to prosper.
